MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MoU) is made and executed at THDC India Ltd Headquarters, Rishikesh on this date of the year 2023.

THDC India Ltd. with its Regd. Office, Bhagirathi Bhawan (Top Tarrace) Bhagirathipuram, Tehri Garhwal 249001 and Corp. Office at Rishikesh set up through its authorized signatory which expression shall unless repugnant to the context or meaning thereof include its successors and permitted assigns of the First part;

AND

Indian Society for Training & Development (ISTD), , a National Body registered under Societies Registration Act with its Office based at B-23, Block B, Qutab Institutional Area, New Delhi (herein after referred to as ISTD), through its authorized signatory, which expression shall unless repugnant to the context or meaning thereof include its successors and permitted assigns of the Second part;

THDCIL and ISTD are herein after individually referred to as 'Party' and collectively as 'Parties'.

Whereas ISTD conducts various Training & Development programmes and is having more than 100 members at present and progressing. The Chapter is organizing MDP, Guest lectures, Presentations, Training and conferences, etc.

Whereas THDC's mission is to provide quality electricity to customers adequately, safely, sustainably at affordable cost and envisages to be the best power utility in India;

The Corp. HRD Centre of THDCIL , Rishikesh namely Takshshila Sustainable Livelihood and Community Development Centre (SLCD) has been conceived as Learning Resource centre for its employees as well as for client organization and stakeholders. With the advent of Phase II (Residential Complex) THDCIL's HRD Centre is poised for conducting Revenue Generation Program.

Now therefore the Parties, through its authorized signatory namely Shri Anoop Kumar, Chairman, ISTD Dehradun Chapter located at 63/1, Rajendra Nagar, Dehradun and THDCIL hereto have agreed to enter into a Memorandum of Understanding (MoU), aimed at facilitating interactions between the two Parties. This MOU shall embody a reciprocal relationship between the two Parties, which shall be guided by the following provisions of the MOU.

IT IS MUTUALLY AGREED BY AND BETWEEN THE PARTIES AS UNDER:

1 Areas of cooperation and collaboration wherein both Parties agreed to execute the following forms of cooperation:-

1.1 THDCIL shall offer infrastructure facilities of its HRD Centre (SLCD) as and when required (Subject to availability on mutual convenient date/days) for learning and training programs organised by ISTD, Dehradun Chapter. The programs shall be designed and executed in mutual Collaboration.

1.2 THDCIL and ISTD, Dehradun Chapter shall seek mutual advice and support in planning and executing Training programs.

1.3 The scope of collaboration will be arrived at with the mutual consent of THDCIL and ISTD, Dehradun Chapter for any kind of training programs, research & consultancy projects.

2 **Confidentiality:** Both THDCIL and ISTD, Dehradun Chapter agree to keep all relevant information and data pertaining to the MOU confidential.

3 **Duration:** This MOU shall be in force from the date on which it is signed, by authorized officials of THDCIL and ISTD, Dehradun Chapter for a period of two years.


4 This MOU is binding on both the Parties. However, any modification concerning the present agreement may be made only by mutual consent in writing between the authorized representatives of both the Parties.


5 **Termination:** This MOU shall come into force as soon as it is signed for all purpose and intents and shall unless earlier terminated by mutual consent, remain in force for a period of two years from the date of signing hereof unless extended or terminated by the Parties by mutual consent in writing. This MOU may be terminated in writing any time by any of the parties providing sixty (60) days prior written notice of its intention.


- 6 The Boarding and Lodging charges for stay at the Sustainable Livelihood and Community Development Centre/HRD Centre, Rishikesh for the Clients/Participants of ISTD, Dehradun Chapter will be in accordance with Circular No. THDCIL/RKSH/HRD/266 dated 20.08.2019 (Annexure I annexed along with the MOU)". However, if there is any revision in the Boarding/Lodging Charges, same shall be applicable to ISTD.
- 7 The Boarding & Lodging charges for ISTD, Dehradun Chapter will be as applicable to Private companies or NGOs.
- 8 THDCIL will provide 10% (ten percent) discount for lodging charges at Participant's Cottage and at VIP Cottages for Residential Programs at the HRD Centre and will also provide 10% (ten percent) discount for hiring hall charges at SLCDC/HRD Centre , Aambagh , Pashulok , Rishikesh to ISTD, Dehradun Chapter having entered into an agreement with THDCIL.
- 9 Governing Law: The present MOU/ contract shall be governed by the Law of India for its time under force. In witness whereof the Parties have signed, sealed and delivered this agreement on this _____
